### MINUTES OF VMC MEETING HELD ON 25-09-2021

A meeting of Vidyalaya Management Committee was held on 25-09-2021 under the chairmanship of Hon'ble Lavkesh Dhruv, Chairman(N) VMC and SDM Khairagarh. Sh S. R. Kujur, Principal KV Khairagarh, welcomed all the members of VMC in the first meeting for the Session 2021-22. The following members were present in the meeting:

The following points were discussed in the meeting:

#### **1. Review of the previous Meeting.**

Mr. S. R. Kujur, Principal, presented Action Taken Report (ATR) of the previous meeting held on 10.03.2021 and reviewed the agenda points, and all the members agreed upon.

**2. Discussion on academic issues- Online Teaching-Learning** Sh. S.R Kujur, Principal, informed the house that all academic activities for classes VI to XII are being conducted in Offline mode and for classes I to V in online mode.

- Periodic Test- I for the Session 2021-22 has been conducted in the month of August as per the guideline of KVS RO Raipur.
- CCT skill tests are being conducted on regular basis as per KVS guidelines.
- Sir also informed the house that the teachers are attending various online training programs, such as NISHTHA 2.0, Implementation of NIPUN Bharat, EBSB, ACP, Foundational Literacy and Numeracy, to enhance their teaching skills and communication, and develop their teaching personality.
- Cluster level CMP meeting for the month of August was organized on 28-08-2021 to discuss various agenda points related to implementation of NEP 2020.

**3. Result Analysis of Session Ending Examination 2020-2021**

Sh. S.R Kujur, Principal, informed the house that the Session Ending Examination 2020-2021 for all classes were conducted successfully through online mode and marksheet was distributed through offline mode. The results for Classes X and XII were prepared as per the CSBE guidelines and marksheet and certificates were distributed accordingly. He also informed the house that the result for the session 2020-2021 for Classes X and XII was qualitatively excellent and 100%.

**4. Land Filling of dug out area in front of the school building.**

Sh. S.R Kujur, Principal, informed the house that land filling of the dug out area in front of the school building is in-progress. Hon'ble Chairman (N) showed promising interest and suggested to write a letter to concerned authority (Nagar Palika) for land filling of dug out area in front of the school with the concrete waste.

**5. Development of Play Ground.**

A discussion was held and suggested that Hon'ble Member of the Parliament can be contacted for the above-mentioned task. Hon'ble Chairman (N) noted the matter for further necessary action by consulting the concerned authority/State Government/Sponsoring Agency.

**6. Creation of local traffic point near the road connecting Vidyalaya.**

A discussion was held on Creation of local traffic point near the road connecting Vidyalaya. Sh. S. R Kujur, Principal, requested to place the Barricades near the road connecting Vidyalaya as a precautionary measure by taking into confidence the local police authority, and all the members agreed for the same.

**7. Internal Whitewash of the school building.**

Sh. S.R Kujur Principal informed the house that the exterior whitewash of the Vidyalaya building is completed as per the reference of Local Purchase Committee. A discussion was held on internal whitewash of the school building. He informed that Internal Whitewash of the school building has to be done with ref. to Local Purchase Committee in this Financial Year. Hon'ble Chairman (N) suggested to send a proposal by following the procurement guideline of KVS and agreed upon to complete the work in time bound manner.

**8. Purchase of Furniture**

Sh. S.R Kujur Principal informed the house that there is shortage of furniture for the Classes VI to VIII, which is to be acquired immediately by following the purchase procedure of the GeM portal on urgent basis, to which the Hon'ble Chairman (N) agreed upon by enquiring the availability of the furniture and reuse of old furniture. He suggested that the old furniture may be donated to the needy organization.

**9. Development of Courtyard in secondary section.**

Sh. S.R Kujur Principal informed the house that the open courtyard area in Primary Section is furnished with cosmic-tiles and the work is completed. Similar courtyard has to be developed in Secondary Section in this financial year. The Hon'ble Chairman (N) agreed upon and suggested to complete the task immediately.

**10. Purchase of Library Books**



**11. Any other point(s) raised by the Chair**




